1. On the storage commencement date, Customer shall either (i) deliver the "vehicle" (motorcycle or trike) to the Initial Pick/up Drop off location set forth on the reverse side hereof at Customer's sole cost and expense or provide Woodstock Harley access to the Motorcycle at the initial pick up/ drop off location.
2. Customer represents and warrants that he/she is the registered owner of the vehicle.
3. **Customers shall pay the FULL of Storage fee, Pick up fee and/or Delivery PRIOR to the Storage commencement date.**
4. **ALL Repairs or installation must be paid when work is completed, not at the end of season.**
5. Woodstock Harley Davidson will determine the storage location where the vehicle will be stored. Woodstock Harley reserves the right to relocate the vehicle to any compatible location.
6. **During the term of this Agreement, Customer's access to the vehicle will be prohibited.**
7. Customer acknowledges that he/she accepts the Storage Location in its "as-in" condition and acknowledges that the Storage Location is satisfactory for his/her purposes.
8. Woodstock Harley Davidson shall connect the vehicle to a battery tender in its sole and absolute discretion to maintain a charge on the motorcycles battery during the term of this agreement ; provided, however, **in no event shall Woodstock Harley Davidson be liable for the failure of or lack of charge in said battery.**
9. Customer represents and warrants that during the term of this Agreement, he/she shall purchase and maintain an insurance policy insuring the vehicle against all loss and damage, including, but not limited to, loss by fire, theft, or other casualty. Customers shall produce a certificate of insurance to WSHD, with such coverages with minimum limits in the amount of the value of the vehicle. Customer's insurance shall at all times be primary. WSHD shall not be obligated to insure the vehicle in any event or amount. Customer, for himself/herself and his/her insurers, hereby waives all rights to assert claims for damage to vehicle against WSHD and/or to claim coverage under WSHD's insurance policies, except to the extent such damage was directly caused by the intentional or negligent acts of WSHD.
10. Customer acknowledges that Customer is responsible for the condition of the vehicle as set forth on reverse side hereof and WSHD shall have no liability for any dings, scratches, or dents noted on the reverse side hereof.
11. Customer agrees to indemnify and hold harmless WSHD and its members, agents, and employees from all claims for damages to the vehicle or personal injury, including reasonable attorneys fees and costs, caused by or arising from the vehicle being stored at WSHD, except for damage directly caused by the intentional or negligent acts of WSHD, Notwithstanding anything otherwise contained herein to the contrary, in no event shall WSHD be liable for any indirect, special or consequential damages of any kind whatsoever.
12. WSHD shall not be responsible for ANY mechanical issues of the vehicle nor personal left with the vehicle. In the event Customer desires WSHD to perform any service work on that vehicle, a separate Proposal/Acknowledgement shall be entered into by Customer prior to the performance of any such service work.
13. **Not less than (5) working days prior to the Storage Termination Date, Customer shall contact WSHD to arrange pick up or delivery of the vehicle.** On a mutually agreeable date on or prior to the Storage Termination Date, Customer shall either (i) pick up the Vehicle from the End of the Season Pick up / Drop off location set forth on the reverse side hereof at Customer's sole cost and expense or (ii) be present at the End of the Season Pick up / Drop off location set forth on the reverse side hereof in order to accept delivery of the vehicle at such location. Notwithstanding anything to the contrary, WSHD shall not be obligated to release and/or deliver the Vehicle to the possession of Customer in the event Customer has not paid to WSHD all outstanding Storage Fees, Pick up Fees, Delivery Fees, and/or any fees incurred for service work performed by WSHD. **Customer shall be assessed a Ninety Nine Dollar (\$99.00) fee for every month or partial month after Storage Termination Date until Customer takes possession of the vehicle.** If customer does not take possession of the vehicle within thirty (30) days of the Storage Termination Date, WSHD shall also have any and all rights and remedies permitted to it under Illinois law including the right to assert a lien against the vehicle and to prosecute such lien in accordance with Illinois Law.
14. This agreement shall not be transferred, subleased, or assigned.

15. This agreement shall be governed by the laws of the State of Illinois.
